

# **REGULATION RELATIVE TO THE ACTIVITY MODEL BUILDING AND CONSERVATION OF THE RAILWAY HERITAGE**

# **To - administrative Part**

### 1. Preamble

This regulation is destined :

to express the will of the countries members of the FISAIC to develop cooperation between their groups of leisure taking to the model building and the conservation of the railway heritage

to fix to this end the principles necessary to his/her/its realization.

### **2.** The convention of the delegates

The meeting of the delegates intervenes in the setting of the international demonstrations to the invitation of the president of the technical commission in agreement with the country promoter. She/it is composed of two delegates by country. To the different votes, every country only has a voice.

### **3.** The technical commission

### a) Election

The convention of the delegates elects 5 or 6 different country members that constitute the technical commission within. Their mandate, of a length of four years, is renewable. This commission also elects a president among his/her members for a mandate of four years renewable.

### b) Working

The national Unions send to the president of the technical commission the questions that they wish to see to discuss at the time of the convention of the delegates. These questions must arrive to the president of the technical commission, at least 6 months before the international exhibition of model building.

### c) Meetings

The technical commission meets on the occasion of every international exhibition, in relation with the country promoter. For that to make, the president of the technical commission addresses to all members an invitation with the agenda at least two months before the date of the meeting.

## d) Decisions :

The decisions are taken to the simple majority of the members. To the various votes, in case of equality of the voices, the one of the president is major.

## e) Report :

He/it belongs to the president of the technical commission to write the report of proceedings. This document is communicated to the secretariat of the FISAIC that sends it then to all countries members.

#### f) Missions :

Are considered like most important missions of the technical commission :

- help to the preparation of international exhibitions of quality,
- management of the technical procedures between two exhibitions, development of propositions and influence on the general development of the activity model building among the countries members of the FISAIC.
- preparation of the modifications either wished necessary of the regulation to submit them to the meeting of the delegates.
- development of the meetings bi and multilateral, of the twinnings...
- cooperation with the presidents of the national commissions of model building of the countries practicing this discipline.

# **B** - technical Part

### 1. Generalities

The international festivals of model building are open to all countries members. In the term model building, it is necessary to distinguish :

- the groups that practice the scale model (construction and convenient)
- the groups that keep and maintain the relegated railway heritage
- the groups that collect the railway objects.

The national Unions of the FISAIC can carry themselves candidates for the organization of such a demonstration by the general secretariat of the FISAIC, during a présidium or a general assembly.

The candidacy must be deposited one year at the latest before the date of the demonstration.

#### **2.**Organization of the international demonstrations

The country promoter wishing the involvement of country members of the FISAIC in his/her/its national exhibition their addresses an invitation that specifies the place, the program of the demonstration and the financial contribution asked the participants.

Joined to this invitation, he/it addresses a form of enrollment including the following demands :

- name of the country participating,
- name and coordinates of the group and the person responsible,
- nature of the material exposition, necessary surface and needs of material (tables, chairs, windows...),

- financial assessment of the material exposition,
- number of participants,
- date back from the document.

In accordance with the interior regulation of the FISAIC, the invited national Unions that cannot participate at the exhibition are prayed to warn the country promoter of it.

The material exposition must be assured.

#### **3.** Validity of the regulation

This regulation, elaborate by the technical commission of model building has been approved by the general assembly of the FISAIC at the time of his meeting September 2006 in Warszawa (Polen).
